#### Introduction

In April 2020, Governor Murphy issued an executive order that became P.L.2020, c.27. This law provides for the continuity of instruction in the event of a public-health-related district closure so that school districts can utilize virtual or remote instruction to satisfy the 180-day requirement pursuant to N.J.S.A. 18A:7F-9. This plan would be implemented during a school district closure lasting more than three consecutive school days due to a declared state of emergency, declared a public health emergency or a directive by the appropriate health agency or officer to institute a public health-related closure. School districts must annually submit their proposed program for virtual or remote instruction (Plan) to the County Office of Education.

The Beach Haven School District has prepared this plan following guidance from the NJ Department of Education and includes these key areas:

### I. Equitable Access and Opportunity to Instruction

All students in grades preschool-6 who are required to work remotely will receive remote instruction aligned with in-person teaching and learning to the greatest extent possible. All district students and staff will have access to Chromebooks and or iPads and chargers available to all students, and will continue to assess technology and connectivity needs.

The plan is as follows:

- The regular school program will continue to the greatest extent possible.
   The elementary instructional day will follow a normal school day, which may include a combination of synchronous and asynchronous instruction.
- Classroom assignments and activities will be posted to Google Classroom.
- Those students who are required to work remotely will receive a Google Meet link from their teacher(s) within one school day of the remote requirement confirmation. The teacher(s) will provide access to direct/teacher-led instruction through Google Meet as necessary. The teacher will periodically check-in with students throughout other portions of the lesson(s) accordingly.

- Teachers will assess students' growth through formative and summative assessments. When digital challenges arise, alternative assignments, projects, and assessments may be provided if needed.
- Families without home Internet access should contact the school for assistance with Internet and technology.
- If a classroom, school, or district needs to transition to a completely remote learning environment, students will follow the regular school schedule (see below). All students will receive a Google Meet link on the first morning of the remote session. Expectations for remote learning will be provided by the district and distributed to students through their classroom teachers.

  Students' individual and age-appropriate needs will be addressed by their teacher through differentiation as needed.

#### **II. Addressing Special Education Needs**

The regular school program will continue to the greatest extent possible. The elementary instructional day will follow a normal school day, which may include a combination of synchronous and asynchronous instruction.

Special education students will have little to no interruption of their instructional program. If necessary, support staff can individualize instruction while being monitored by the classroom teacher. Special education case managers will work collaboratively with the teaching staff and families remotely to track and ensure that services are implemented according to IEPs to the greatest extent possible.

IEP meetings, evaluations, and other meetings to identify, evaluate, and/or reevaluate students with disabilities will be scheduled using a Google Meet link provided by the case manager. In-person or alternative methods will be considered as needed and when possible.

#### III. Addressing English Language Learner (ELL/ML) Plan Needs

Students who are English Language Learners will have uninterrupted virtual and remote instruction. All ELL/ML students will engage with their services using a modified schedule as needed so that ELL/ML services can be delivered in

partnership with Classroom teachers to differentiate and communicate with families to address any barriers to learning. Translation materials will be provided to students and families where appropriate. A bilingual interpreter can be made available for meetings and communications where needed.

Educational training materials are provided to all staff on Universal Design for Learning (UDL), culturally responsive teaching and learning, socio-emotional learning, and trauma-informed teaching for students affected by forced migration from their home country

#### IV. Attendance Plan

Attendance is taken at the beginning of the day. Elementary students must log in at the beginning of the school day and will remain logged in to the class as directed by their teacher. Students must have their computer cameras on so they can be marked as "present." The district attendance policy will be followed. Parents will be notified by the school nurse or the main office if a student is marked absent.

- If a child or staff member requires additional social and emotional health support, our school counselor will be available to communicate with them as needed.
- The school district will continue to support student interventions through RTI/I&RS based on individual needs. Students will receive small-group or one-on-one support to address goal areas identified for basic skills, 21st
   Century Community Learning Centers, and the needs of any Title I students.
