Dear Parents/Guardians:

This notice is being distributed to comply with the New Jersey School Integrated Pest Management Act. The Beach Haven Borough School District has adopted an Integrated Pest Management (IPM) Policy and implemented an IPM Plan to comply with this law. IPM is a holistic, preventative approach to managing pests, explained further in the school's IPM Policy.

All schools in New Jersey are required to have an Integrated Pest Management Coordinator who oversees all activities related to IPM and pesticide use.

The IPM Coordinators maintain the pesticide product labels and, when available, the Safety Data Sheets (SDS) for each pesticide product that may be used on school property. The label and the SDS are available to parents, guardians, and staff members for information and to discuss comments about the school's IPM activities and pesticide use.

As part of the school's Integrated Pest Management Plan, the Beach Haven Borough School District may use pesticides to control pests. The United States Environmental Agency (EPA) and the New Jersey Department of Environmental Protection (DEP) register pesticides to determine that the use of a pesticide in accordance with instructions printed on the label does not pose an unreasonable risk to human health and the environment. Nevertheless, unnecessary exposure to pesticides should be avoided. The EPA has issued the statement that, where possible, potentially sensitive persons, such as pregnant women, infants, and children, should avoid unnecessary pesticide exposure.
