Kindergarten New Student Registration 2025/2026

Entrance Requirements

All children entering Beach Haven School's Kindergarten Program in the 2025-2026 school year must meet the following requirements:

- Kindergarten only - The child must be **five** years old on or before October 1, 2025.
- An original birth certificate* must document the child's birth date.
- A current physical examination, performed during the last 365 days, is required for all kindergarten students.
- Two proofs of residency that you live within the Beach Haven District must be presented for in-district students.
- Two proofs of residency must be presented for out-of-district students. (Choice students only)
- Proof of required immunizations (See Page 2)

There are Two Steps to the Registration Process

Step 1: Registration Application Packet:

- Print or fill out the registration packet and complete it in its entirety
- Fill out the Beach Haven Home Language Survey
- Scan or email the completed packet to Kimberly Carey at kcarey@beachhavenschool.com
- If you are unable to scan or email the packet, mail it to 700 North Beach Ave, Beach Haven, NJ 08008


Step 2: Document Verification*

These documents must be verified in person:

- An original birth certificate with parents' names and raised seal.
- Registration Affidavit - must be signed in front of the registration official once residency is verified.

Kindergarten Immunization Minimum Requirements:

Diphtheria, tetanus & acellular pertussis (DTaP)	<u>Four</u> doses with one of these doses on or after the fourth birthday. Alternatively, any 5 doses are acceptable. ¹
Inactivated Poliovirus Vaccine - IPV (Polio)	<u>Three</u> doses with one of these doses on or after the fourth birthday. ²
Measles, mumps, rubella (MMR)	<u>Two</u> doses ³
Varicella (VAR)	<u>At least one</u> dose given on or after the first birthday ⁴
Haemophilus influenzae type B (Hib)	<u>Three</u> doses

¹ DTaP: Children who previously attended child care/preschool should have received 4 doses since the requirement to receive the fourth birthday booster dose (5th dose) does not apply until they attend Kindergarten. However, if one of these 4 doses was given on or after the 4th birthday, an additional dose is not needed for Kindergarten. Alternatively, any 5 doses are acceptable.

² Polio: Children who previously attended child care/preschool should have 3 doses since the requirement to receive the fourth birthday booster dose (4th dose) does not apply until they attend Kindergarten. However, if one of these 3 doses was given on or after the 4th birthday, no additional doses are needed for Kindergarten. Alternatively, any 4 doses are acceptable.

³ MMR: Children must receive two doses of measles, one dose of mumps, and one dose of rubella once they enter Kindergarten. Since single antigen (separate vaccine components) is not readily available, most children will have two MMR vaccines.

⁴ Varicella vaccine is only required for children born on or after January 1, 1998. Children who previously had chickenpox do not need to receive the varicella vaccine as long as a parent/guardian can provide the school with one of the following: 1) Documented laboratory evidence showing immunity (protection) from chickenpox, 2) A physician's written statement that the child previously had chickenpox, or 3) A parent's written statement that the child previously had chickenpox.
